**AUTHORIZATION and TERMS AND CONDITIONS:**

The “Authorized Customer Representative” herein referred to as “Customer” hereby authorizes BGE, Pepco, Allegheny Power, Delmarva Power or local EDC to permit the authorized “Licensed Electricity Service Supplier” or “Licensed Natural Gas Service Supplier” to directly receive “Customer’s” most recent twenty-four (24) months electricity or natural gas account data and twelve (12) months of payment history for the Account Numbers with meters located at the address entered in the account information section on the following screen. The electric billing or natural gas billing information may include information on service configuration, transformers, and descriptions of previous energy use. The authorized “Licensed Electricity or Natural Gas Service Supplier” has the right to use the information provided and to retain the information in its files, and disclose it to any authorized employee, agent, or representative. The authorized “Licensed Electricity or Natural Gas Service Supplier” hereby agrees not to sell

or otherwise disclose the information obtained to any third party not authorized in writing by "Customer," for the purposes of such third party marketing to or soliciting business from "Customer." "Customer" hereby authorizes "Licensed Electricity or Natural Gas Service Supplier" to process this Application for credit review and approval. All information provided will be held in strict confidence and used only by "Licensed Electricity or Natural Gas Service Supplier" or its affiliates, in making its credit evaluation.

The "Customers" application and credit information will be reviewed by the "Licensed Electricity or Natural Gas Supplier." Based on your credit rating and payment history the "Licensed Electricity or Natural Gas Supplier" has the right to reject your application. If that is the case, the "Customer" will not be offered a contract and not included in the Purchasing Cooperative. CQI Associates will refund your application fee minus the credit card processing fee.

The applicant understands that market prices and regulations impact the terms, time, and rates of the supplier offers. The current utility company "Default or Standard Offer Rates" are used as the "price to compare" or "benchmark price" to determine if a supplier's offer is economically viable. A significant period of time could elapse from the date the application is submitted and the time when market rates drop to a point where a price offer will be recommended that is lower than the current or projected utility company "Default or Standard Offer Rates". The application fee is non-refundable.

**Payment: \$37.50 per account number**

***Each location may have more than one account number, but participation is per location, not per account number. Owners with more than one location need to complete an Application Form per location and pay the fee of \$35.00 per location. Gas is an individual fee of \$30.00 per location.***
